# Murphysboro City Council Meeting July 25, 2017

The Murphysboro, Illinois, City Council met in regular session, pursuant to its ordinances, on the 25<sup>th</sup> day of July 2017. Mayor Stephens called the meeting to order at 6:00 p.m. and led the council in prayer. Following the invocation, Mayor Stephens led the council in the pledge of allegiance to the flag. Mayor Stephens then directed City Clerk Cottonaro to call the roll. The roll was called with the following

Police Chief Roberts introduced new officers Aaron Beavers, Taylor Riggs and Brendan Mier to the council. Chief Roberts informed the council of the promotion of William Jacob Weber to the rank of Sergeant and requested his wife Alix Weber present his pin. Police Chief announced that Brian Brewer was hosting a retirement party on August 5<sup>th</sup> and again mentioned the retirements of Tim LeGere and Ed Reiman.

Motion: To approve the minutes of the July 11 2017 council meeting. All aldermen received a copy of the minutes, for their review, prior to the meeting. Motion by Alderman McComb Second by Alderman Brown Mayor called for a voice vote. All were in favor.

Alderman McComb requested to hold the \$3800 check to Murphysboro Lawn & Garden until he talks to Tom.

All aldermen received a copy of the accounts payable, accounts receivable and payroll for their review, prior to the meeting.

#### COMMITTEE/COMMISSION REPORTS

Alderman Pittman opened the Budget & Finance Meeting.

Mayor Stephens stated the meeting with Jackson County Mass Transit regarding the transportation needs of the Senior Citizens Center resulted in their willingness to dedicate a van so many days a week for seniors to use. However, Joe Balsano felt having their own van gives them more flexibility. Council thought that if they want a 5 day a week service we could give them the van and let them sell it and buy a different one more suitable for their use. Mr. Balsano thought that they would be willing to give up either the fuel or the maintenance dollars that we currently budget yearly. Attorney Blake advised that we could give them the van. Mayor Stephens stated we would look at it again in November. A suggestion was made to continue support for one year from now because they think they can get raise the money to purchase a different vehicle. We could give them one year to see if they can raise the money. Also this gives JCMT this year to clean up their act. We will hold this issue for one more meeting.

Public comment: need a van not mass transit.

Consideration of proposal for part-time grant writer. Attorney Blake stated we need to decide on options for payments if we got a large grant amount. Alderman Pittman has an issue with the percentage payment structure and also would like a lower maximum cap. Alderman Voss stated that if the percent is in line it is okay with him. Attorney Blake stated we need a termination clause so that the city or Brian can get out of the contract in so many days if it is not working. Mayor Stephens stated we should get the termination clause. Alderman Pittman will do research with regard to comparable rates. Alderman Pittman stated that since this is on a commission only basis he would like to see it open to multiple people since we aren't paying until we get grant dollars.

Smysor Trust has funded the landscaping and maintenance of Town Park Center and Smysor Plaza at \$9000; summer concerts at \$4500. The five concerts are held every Thursday in August.

They also gave the city \$65,000 to be used to initiate an awning program and if it can't be accomplished we are allowed to apply the funds toward a bucket truck. Our current bucket truck is out of service and we cannot do things we need to do. The

Park District is interested in the old bucket truck; perhaps we can work something out with them. Price of bucket truck is from \$48,000 up to \$65,000 for a 2013. Alderman Bastien stated we should get the truck and if we can get grant dollars then do awnings.

Smysor Trust Board also funded Murphysboro Main Street Committee Inc.

Financial reports presented by Scott Evans and discussed were as follows: Schedule of Operating Expenses by Department vs. Budget, Comparison of Budgeted vs. Actual Payroll, Schedule of Healthcare Costs, Schedule of State Income Tax Receipts Vouchered, Schedule of Sales/HR Tax Receipts, Schedule of Costs Related to WWTP Construction, Water/Sewer Fund.

No public comment.

Alderman McComb opened the Building and Grounds Meeting.

James Kimmel filed a complaint requesting \$15,000 for water damage. Alderman McComb stated that the water comes from the church parking lot and part goes in the drain and part runs across the neighbor's yard and then into Mr. Kimmel's property. Our insurance has denied this claim. There has been a water problem there for years. Alderman Erbes inquired if Mr. Kimmel had turned a claim into his insurance. Attorney Blake stated the insurance company said the city is not liable and they would handle any litigation. The drain is located in Mr. Kimmel's yard and he says it gets clogged up and we don't clear it out as we should. Darrin has rebuilt the drain so it should not happen again.

Alderman Bratton asked about vines, grass in sidewalk if that was included in maintenance. Alderman McComb thinks we will be a few thousand under budget. Contact is up at the end of February.

Osburn Street extension updated. Bishop and Elwell met with IDOT engineers and IDOT said there was no way to allow them to build on that site. There is the issue of additional traffic flow not at a signaled intersection. Elected officials to get involved to break IDOT rules.

Tim Lee is on vacation and still looking for bids on lining for sewer lines.

Discussion was held regarding the billboard request by Chris Grither. B2 zoning does not allow billboards. Alderman Bratton suggested we look at the map and ordinance and check it out. If we do allow one we have to do the same for everyone. It would allow a billboard every 500 feet. B2 zone is 14<sup>th</sup> Street, Industrial Park and river to Wal Mart. Amendment of text of zoning code goes to the zoning board.

Motion: To approve the Motor Fuel Resolution for the 2017 Oil & Chip Program in the amount of \$59,734.
